gsLearn Platform Terms of Use

LAST UPDATED: July 8, 2019

CAREFULLY READ THE TERMS AND CONDITIONS set forth in this TERMS OF USE ("AGREEMENT") installing or using this SITE or APPLICATION offered through the gsLearn SITE and APPLICATION, as they explain your obligations and rights with respect to the download, installation, access to and use of the site and Application and related Services (as defined below), including intellectual property ownership rights in the materials and your responsibilities with respect to use of the gsLearn platform.

By using the pages on this site or by downloading, installing and/or using the APPLICATION or the SITE, or interacting with any features of the platform or gsLearn services, you signify your agreement to be bound by all of (1) the terms and conditions set forth in this AGREEMENT and (2) our Privacy Policy located at <https://www.girlscouts.org/en/help/help/privacy-policy.html>.

You affirm that you are over the age of thirteen (13) and, if you reside outside the United States, are over the age of sixteen (16), and are fully able and competent to enter into the terms, conditions, obligations, affirmations, representations and warranties set forth in this AGREEMENT, and to abide by and comply with this AGREEMENT.

Agreement. This AGREEMENT is between you and GIRL SCOUTS OF THE USA (GSUSA). Your wireless service provider is not a party to this AGREEMENT.

Account. In order to access features of the Service, you will have to create a gsLearn platform Account. You may never use another's account without permission.

When creating your account, you must provide accurate and complete information. You are solely responsible for the activity that occurs on your account, and you must keep your account password secure. You must notify GSUSA immediately of any breach of security or unauthorized use of your account by emailing CEPsupport.girlscouts.org. Although GSUSA will not be liable for your losses caused by any unauthorized use of your account, you may be liable for the losses of GSUSA or others due to such unauthorized use.

You are exclusively responsible for your own conduct on or through the SITE or the APPLICATION. You use the SITE and APPLICATION at your own risk.

Limited License. GSUSA grants to you a worldwide, non-exclusive, limited license or equivalent right to download, install and/or use the SITE and object code version of the APPLICATION (referred to below as the "Licensed Application") and to use the Services and features contained in the gsLearn platform on your computer or wireless communications device. All rights not expressly granted in this AGREEMENT are reserved by GSUSA. This license granted to you for use of the Site and Licensed Application by GSUSA is limited to a non-transferable license to use the Site and Licensed Application on any computer or mobile device that you own or control in accordance with this license and any usage rules posted by GSUSA in connection with the Site or Licensed Application. This license does not allow you to use the Site or Licensed Application on any device or mobile device that you do not own or control, and you may not distribute or make the Licensed Application available over a network where it could be used by multiple devices at the same time. You may not rent, lease, lend, sell, redistribute or sublicense the

Licensed Application or Access to the Site. You may not copy (except as expressly permitted by this license and any additional or subsequent usage rules posted by GSUSA in connection with the Site or Licensed Application), decompile, reverse engineer, disassemble, attempt to derive the source code of, modify, or create derivative works of the Site, Licensed Application, any updates, or any part thereof (except as and only to the extent any foregoing restriction is prohibited by applicable law or to the extent as may be permitted by the licensing terms governing use of any open sourced components included with the Licensed Application). Any attempt to do so is a violation of the rights of the GSUSA and its licensors. If you breach this restriction, you may be subject to prosecution and damages. The terms of the license will govern any upgrades provided by GSUSA that replace and/or supplement the original product, unless such upgrade is accompanied by a separate license in which case the terms of that license will govern.

Other Software. Notwithstanding any other provision of this AGREEMENT, this AGREEMENT shall not be deemed to apply to any software that is licensed to you by third parties and that is included on your wireless communications device (“OTHER SOFTWARE”). Any such OTHER SOFTWARE is subject to the terms and conditions of the AGREEMENT, if any, between you and GSUSA or licensor of the OTHER SOFTWARE.

Restrictions. No license is granted to you by this AGREEMENT in the human readable code, known as the source code, of the APPLICATION or the SITE. In addition, no license is granted to you by this AGREEMENT to decompile, reverse engineer, disassemble or modify the SITE or APPLICATION. Further, no license is granted to you by this AGREEMENT to (i) remove, efface or obscure any copyright or other proprietary notices from the SITE or APPLICATION or (ii) exploit, copy, reproduce, sublicense, transfer or assign the SITE or APPLICATION.

Except for the limited license granted to you under this AGREEMENT, all right title and interest in the SITE and APPLICATION and the content, information and other materials provided by GSUSA on the SITE and APPLICATION (collectively, the “Content”), and all copies, modifications and derivative works thereof, is and will remain the sole and exclusive property of GSUSA. No rights are granted to you by this AGREEMENT in any patents, copyrights, trade secrets, trademarks or any other rights in respect of the SITE, APPLICATION or Content. The SITE, APPLICATION and the Content are protected by copyrights, trademarks, trade dress, and/or other intellectual property or proprietary rights and are owned, licensed, or controlled by Girl Scouts of the USA or its licensors.

All right, title and interest in and to any GSUSA provided trademarks, GSUSA-provided service marks, and GSUSA-provided program collateral included on the SITE or APPLICATION, or otherwise provided by GSUSA for use with the foregoing, including all related logos, designs, imagery and Content are proprietary to GSUSA and/or its licensors.

For purposes of these terms, the use of any such material on any other website or computer environment is prohibited. No right, title, or interest in any downloaded Content or software is transferred to you as a result of any such downloading or copying. You may not reproduce (except as permitted in these Terms), publish, transmit, distribute, display, modify, create derivative works from, sell or participate in any sale of, or exploit in any way, in whole or in part, any of the Content, the site, or any related software.

Additionally, you agree that you will not:

- (a) disassemble, decompile, reverse-engineer, copy, translate or make derivative works,

(b) transmit any content or data that is unlawful or infringes any intellectual property rights, or

(c) circumvent or endanger its operation or security, or

(d) use for any commercial purpose or in high-risk activities including, without limiting the generality of the foregoing, in any direct or active operations of any equipment in any nuclear, aviation, mass transit, or medical applications, or in any other inherently dangerous operation.

Ownership. You agree that GSUSA retains all right, title and interest in and to the SITE and APPLICATION and all copies of the SITE and APPLICATION.

Wireless Network Usage. The APPLICATION may send and receive data over your wireless service provider's network. Standard data service charges may apply. Check with your wireless service provider for additional information.

Consent to Use of Data. To facilitate product support and other services to you, you agree that GSUSA may collect, use, store, and transmit non-personally identifiable technical and related information that identifies your mobile device, operating system, software and peripheral hardware. In addition, GSUSA may collect and store non-personally identifiable APPLICATION and SITE usage statistics. Additionally, GSUSA may use this information in the aggregate, in a form which does not personally identify you, to improve our products and services and we may share anonymous aggregate data with our third party service providers or share such data to our third party service providers to enable them to provide services to us. GSUSA may store any personal information you enter on our service or provide to us in any other way. The types of personal information collected may include, among other things, your name, user name, address, email address, phone number, and birth date. The personal information you provide may also be used for such purposes as customizing content you see, and communicating with you about specials and new features. GSUSA's use of such information shall be subject to the terms of GSUSA's Privacy Policy.

Consent to License Grant. If you provide to GSUSA any ideas, proposals, suggestions, or other materials ("Feedback"), whether related to the SITE, APPLICATION, CONTENT or otherwise, you hereby acknowledge and agree that such Feedback is not confidential, and you hereby grant GSUSA a fully paid and royalty-free, worldwide, perpetual and irrevocable license to use, modify, delete from, add to, publicly perform, publicly display, prepare derivative works based on, reproduce and translate any Feedback, without compensation, without any obligation to report on such use, and without any other restriction.

Although GSUSA may from time to time monitor or review postings, transmissions, User Generated Content and the like used on and in connection with the APPLICATION and the SITE, GSUSA is under no obligation to do so and assumes no responsibility or liability arising from any User Generated Content nor for any error, defamation, libel, slander, omission, falsehood, obscenity, pornography, profanity, danger or inaccuracy contained in any User Generated Content and/or information utilized or created in connection with the APPLICATION and the SITE. You represent, warrant and covenant that no materials of any kind submitted by you, including without limitation User Generated Content will (i) violate, plagiarize, or infringe upon the rights of any third party, including copyright, trademark, privacy or other personal or proprietary rights; or (ii) contain libelous or otherwise unlawful material.

Indemnity. You hereby indemnify, defend and hold harmless Girl Scouts of the USA, Girl Scout councils, and all of their officers, directors, employees, owners, agents, information providers, affiliates, licensors and licensees, and subcontractors (collectively, the "Indemnified Parties") from and against any and all liability and costs, including, without limitation, reasonable attorneys' fees, incurred by the Indemnified Parties in connection with any claim arising out of (i) any breach by you or any user of your account of this AGREEMENT, including the representations, warranties and covenants set forth herein, or otherwise arising out of your download, installation or use of the SITE, APPLICATION, any Services, or any content or feature made available via the APPLICATION or Services. You shall cooperate as fully as reasonably required in the defense of any such claim. GSUSA reserves the right, at its own expense, to assume the exclusive defense and control of any matter subject to indemnification by you.

Release. You hereby agree on behalf of yourself, and your heirs, next of kin, spouse,

guardians, legal representatives, executors, administrators, successors and assigns (collectively, the “Releasing Parties”), that you and the other Releasing Parties do hereby unconditionally and irrevocably release and forever discharge GSUSA, Girl Scout councils and their employees, officers, directors, owners, agents, information providers, affiliates, licensors and licensees, successors, assigns, partners, and related companies, and the officers, directors, employees, contractors, partners, shareholders, representatives, members and agents of each of the foregoing, and any other person or entity associated with the SITE or APPLICATION (collectively the “Released Parties”), from and against any and all claims, demands, liens, agreements, suits, costs, attorney’s fees, damages, judgments, orders, and liabilities of whatever kind or nature in law, equity or otherwise, whether known or unknown, suspected or unsuspected, and whether or not concealed or hidden (collectively the “Released Claims”), in any way directly or indirectly arising out of or relating in any way to: (i) your download of, installation, access to or use of the SITE or APPLICATION, any Services, or any content or feature made available via the SITE, APPLICATION or Services; (ii) the use of, or failure to use, the User Generated Content; and/or (iii) breach of this AGREEMENT. Nothing hereinabove will constitute any obligation on the part of GSUSA or any Girl Scout council to make any use of any of the rights set forth above.

Digital Millennium Copyright Act

A. If you are a copyright owner or an agent thereof and believe that any content posted to the gsLearn platform infringes upon your copyrights, you may submit a notification pursuant to the Digital Millennium Copyright Act (“DMCA”) by providing our Copyright Agent with the following information in writing (see 17 U.S.C 512(c)(3) for further detail):

- A physical or electronic signature of a person authorized to act on behalf of the owner of an exclusive right that is allegedly infringed;
- Identification of the copyrighted work claimed to have been infringed, or, if multiple copyrighted works at a single online site are covered by a single notification, a representative list of such works at that site;
- Identification of the material that is claimed to be infringing or to be the subject of infringing activity and that is to be removed or access to which is to be disabled and information reasonably sufficient to permit the service provider to locate the material;
- Information reasonably sufficient to permit the service provider to contact you, such as an address, telephone number, and, if available, an electronic mail;
- A statement that you have a good faith belief that use of the material in the manner complained of is not authorized by the copyright owner, its agent, or the law; and
- A statement that the information in the notification is accurate, and under penalty of perjury, that you are authorized to act on behalf of the owner of an exclusive right that is allegedly infringed.

You may direct copyright infringement notifications to our DMCA Agent at Copyright Agent, GSUSA, 420 Fifth Avenue, New York, NY 10018; email: dmca@girlscouts.org. For clarity, only DMCA notices should go to the Copyright Agent; you should direct any requests for technical support to your local Girl Scout council. You acknowledge that if you fail to comply with all of the requirements of this Section, your DMCA notice may not be valid.

B. Counter-Notice. If you believe that your content that was removed (or to which access was disabled) is not infringing, or that you have the authorization from the copyright owner, the copyright owner's agent, or pursuant to the law, to post and use the material in your content, you may send a counter-notice containing the following information to the Copyright Agent:

- Your physical or electronic signature;
- Identification of the content that has been removed or to which access has been disabled and the location at which the content appeared before it was removed or disabled;
- A statement that you have a good faith belief that the content was removed or disabled as a result of mistake or a misidentification of the content; and
- Your name, address, telephone number, and e-mail address, a statement that you consent to the jurisdiction of the federal court in New York, New York, and a statement that you will accept service of process from the person who provided notification of the alleged infringement.

If a counter-notice is received by the Copyright Agent, GSUSA may send a copy of the counter-notice to the original complaining party informing that person that it may replace the removed content or cease disabling it in 10 business days. Unless the copyright owner files an action seeking a court order against the content provider, member or user, the removed content may be replaced, or access to it restored, in 10 to 14 business days or more after receipt of the counter-notice, at GSUSA's sole discretion.

Account Termination Policy. GSUSA will terminate a user's access to the Service if, under appropriate circumstances, the user is determined to be a repeat infringer. GSUSA reserves the right to decide whether content posted by any users violates this AGREEMENT for reasons other than copyright infringement, such as, but not limited to, pornography, obscenity, or excessive length. Your access to the

APPLICATION and the SITE, and any other Girl Scouts of the USA sites and applications may be terminated immediately without notice if in our sole discretion you fail to comply with any term or provision of these terms. Upon termination, you must remove the APPLICATION from all your devices, cease all use of the APPLICATION and the SITE, and destroy all Content obtained from the APPLICATION and the SITE and all related documentation and copies and installations thereof, whether made under these terms or otherwise.
